

## 2025 President of the CNUE

### Ms. Cosita DELVAUX

Ms. Cosita DELVAUX, President of the CNUE for 2025, has been a notary in LUXEMBOURG (Grand Duchy of LUXEMBOURG) since 2014 and was appointed notary for the first time in 2011 in REDANGE-SUR-ATTERT.

Ms. DELVAUX has been a member of the Chamber of Notaries of the Grand Duchy of Luxembourg since 2014 and served as Secretary from 2018 to 2023.

Since its creation, Ms. DELVAUX has been a member of the commission responsible for setting up and developing the digitalisation of the notariat and of the commission for combating money laundering and the financing of terrorism within the Chamber of Notaries.

Ms. DELVAUX is a delegate of the Luxembourg notariat in the Commission for European Affairs of the International Union of Notaries and has been a delegate of the Luxembourg notariat in the CNUE Company Law working group.

Ms. DELVAUX has been appointed, since a ministerial decree of 15 November 2019, member of a special working group responsible for studying, under the authority of the Ministry of Justice, the reform of commercial company law within the framework of the Commission for Legislative Studies.

Ms. DELVAUX is also a lecturer in company law, anti-money laundering and the financing of terrorism, notarial law and ethics as part of the notarial traineeship under the authority of the Ministry of Justice. Previously, she taught liquidation – indivisum sharing in the context of successions and divorces and was also an associate lecturer at the University of Luxembourg, where she taught the introductory course in company law.

She has been appointed by ministerial decree as a member of the examination board at the end of the traineeship for notaries-candidates since 2014.



Before becoming a notary in 2011, Ms. DELVAUX gained extensive experience, as a lawyer at the Court and as a lawyer in banking institutions. During her university career, she obtained a master's degree in private law in 1993 and a bachelor's degree in economic and social administration in 1994.

Ms. Cosita DELVAUX was born on 27 February 1967, is married and has 3 children.
